

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 4019
OFFERED BY MR. HEINRICH

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “County Payments Re-
3 authorization Act of 2012”.

**4 SEC. 2. SECURE RURAL SCHOOLS AND COMMUNITY SELF-
5 DETERMINATION PROGRAM.**

6 The Secure Rural Schools and Community Self-De-
7 termination Act of 2000 (16 U.S.C. 7101 et seq.) is
8 amended—

9 (1) in section 3(11)—

10 (A) in subparagraph (A), by striking
11 “and” after the semicolon at the end;

12 (B) in subparagraph (B)—

13 (i) by striking “fiscal year 2009 and
14 each fiscal year thereafter” and inserting
15 “each of fiscal years 2009 through 2011”;
16 and

17 (ii) by striking the period at the end
18 and inserting “; and”; and

1 (C) by adding at the end the following:

2 “(C) for fiscal year 2012 and each fiscal
3 year thereafter, the amount that is equal to 95
4 percent of the full funding amount for the pre-
5 ceding fiscal year.”;

6 (2) in sections 101, 102, 203, 207, 208, 304,
7 and 402, by striking “2011” each place it appears
8 and inserting “2016”;

9 (3) in section 102—

10 (A) by striking “2008” each place it ap-
11 pears and inserting “2012”;

12 (B) in subsection (b)(2)(B), by inserting
13 “in 2012” before “, the election”; and

14 (C) in subsection (d)(3)(A)(i)—

15 (i) by striking “An eligible county”
16 and inserting “The Governor of each eligi-
17 ble State”; and

18 (ii) by striking “by the” and inserting
19 “by an”;

20 (4) in section 103(d)(2), by striking “fiscal year
21 2011” and inserting “each of fiscal years 2011
22 through 2016”;

23 (5) in section 202, by adding at the end the fol-
24 lowing:

1 “(c) ADMINISTRATIVE EXPENSES.—A resource advi-
2 sory committee may, in accordance with section 203, pro-
3 pose to use not more than 10 percent of the project funds
4 of an eligible county for any fiscal year for administrative
5 expenses associated with operating the resource advisory
6 committee under this title.”;

7 (6) in section 204(e)(3)(B)(iii), by striking
8 “and 2011” and inserting “through 2016”;

9 (7) in section 205(a)(4), by striking “2006”
10 each place it appears and inserting “2011”;

11 (8) in section 302(a)(2)(A), by inserting “and”
12 after the semicolon; and

13 (9) in section 304(b), by striking “2012” and
14 inserting “2017”.

15 **SEC. 3. PAYMENTS IN LIEU OF TAXES.**

16 Section 6906 of title 31, United States Code, is
17 amended by striking “2012” and inserting “2017”.
